This acquisition follows the successful acquisition of Office & General Group Limited (O&G), the leading UK based Facility Management Company in August 2015.

The acquisition of Frontline Security establishes Tenon as a credible player in the Security & Facility Management in the Asian market and will benefit the clients on both domestic and international level. It will give the Company a competitive edge while allowing it to offer a range of services in the Integrated Facility & Security Management domain across multiple geographies. It will also create efficiencies that will provide flexibility for the company to invest in people, technology and products and as well as improve the company's business profile. Through the two acquisitions – O&G and Frontline, Tenon has evolved into a Multinational Corporation offering enhanced level of global services across the spectrum of Security and Facility Management Services.
